Changing the Game



The Atlantic Philanthropies' grant of \$12 million to the National Museum of African American History and Culture enables the Smithsonian to continue sharing the diverse stories that are vital to our collective national identity. The Atlantic Philanthropies' grant supported the museum's capital campaign and funds transformative dialogues about race, identity, racial equity, exclusion, inclusion and reconciliation through programming and digital learning resources for the public, including educators, students and learners, parents and caregivers. The Atlantic Philanthropies' grant helps complete the picture of the American experience by creating greater awareness and clarity among museum visitors of the history and cultural diversity reflected in our collective heritage.



In support of the summer 2017 opening of American Democracy: A Great Leap of Faith at the National Museum of American History, a combined \$6 million gift and bequest intention by Linda and Pete Claussen endows and supports the exhibition's opening and continuing programming. The Linda and Pete Claussen Hall of American Democracy will host the exhibition, which explores the nation's commitment to popular sovereignty and the ideals and ideas of a democracy. Pete Claussen is a past chairman of the museum's board and has served on the Smithsonian National Board and National Portrait Gallery Commission. Committed friends of the Smithsonian since 1997, the Claussens also donated the 44-seat segregation-era Southern Railway car now on exhibit in the National Museum of African American History and Culture.



In Germany in 1936, African American sprinter Jesse Owens shattered barriers and perceptions by demonstrating that race was no impediment to his ability to compete and win in the Olympics. Generations of African American athletes who followed him used sports to overcome racial obstacles and gain participation in American society. A \$5 million gift by Michael Jordan and Family to the National Museum of African American History and Culture celebrates the many African American athletes whose actions both on and off the field transformed sports, the nation and the world. The museum's Game Changers Hall of the Sports Gallery, named in honor of his generosity, features the personal objects and stories of those who have used the power of sports to advance civil rights, including one of Michael Jordan's own jerseys from the 1996 National Basketball Association Finals.



Faith and religion have long been intertwined in American history, influencing virtually every facet of society and culture. Within the African American community, religion has been a pillar of daily life. To advance research, educational programming and preservation of artifacts related to faith as experienced through an African American lens, a gift of \$10 million by Lilly Endowment Inc. supports the creation and endowment of the Center for the Study of African American Religion at the Smithsonian's newest museum. A separate gift of \$5 million from Lilly Endowment Inc. endows a curatorship of American religious history at the National Museum of American History. Each of these gifts enables the Smithsonian not only to better tell the personal stories of spiritual practice and interpret American religious freedom throughout history, but also to partner with faith communities across the country to preserve local histories and cultures. Lilly Endowment Inc. has supported the Smithsonian since 1973.



David M. Rubenstein's gift of \$10 million to the National Museum of African American History and Culture helped build and open the museum building. The National Mall facility is a place for reflection upon four centuries of the nation's history and a catalyst for discussion of the impact of the African American experience on every aspect of the American character. The three History Galleries are named in honor of David Rubenstein in recognition of this generous gift, and in them will be displayed two rare documents on loan from him: the 13th Amendment and the Emancipation Proclamation, the latter signed by President Abraham Lincoln. As well as chairing the Smithsonian Board of Regents, David Rubenstein co-chairs the Smithsonian Campaign, serves on the board of the National Museum of Natural History and is a former board member of the National Museum of American History, His generosity has extended across the Smithsonian to the National Zoological Park, Smithsonian American Art Museum, National Museum of Natural History and National Museum of American History.



Like the blend of America's diverse cultural backgrounds, America's folk music cannot be characterized by a simple description. From blues and jazz, to country, gospel, zydeco and more, Chris Strachwitz of Arhoolie Records traveled America's back roads for more than 50 years to capture and collect as many of its folk sounds he enjoyed as possible. A \$5 million gift by Edmund and Laura Littlefield of the Sage Foundation made it possible for the Smithsonian Center for Folklife and Cultural Heritage to receive Arhoolie Records' master recordings and related materials and add them to the collection. Through the center's Smithsonian Folkways label, Arhoolie's rich and uniquely American musical legacy of hundreds of seminal folk artists, among them Big Mama Thornton, Mance Lipscomb and Flaco Jiménez, will continue to be available to listeners around the world. Connection, Ownership, Pride

ROBERT FREDERICK SMITH



A \$20 million gift from Robert Frederick Smith to the National Museum of African American History and Culture provides \$5 million to build the new museum facility and a further \$15 million to advance the museum's digitization, community outreach and internship and fellowship programs. These three programs will expand the museum's ability to share African American history and culture with audiences across the nation and around the world. The Digitization Program will enable the museum to acquire, preserve and digitize collections of a wide array of African American artists and organizations. The gift provides funding to license these works for educational purposes and build a sophisticated digital platform to make them freely accessible. Through the Community Outreach Program, the museum will enhance its partnerships with community-based organizations in key cities across the nation. The gift funds the development of the digital tools or "apps" that will enable those communities to digitize and upload images and documents and share them with others. By allowing individuals and families to contribute and curate their own stories, pictures and more, the museum can weave the story of all African American families into a narrative about the African American

experience. The intent of the donor is to create the connection, ownership and pride in the history of all African American families. The Internship and Fellowship Program provides resources to offer professional development opportunities for the next generation of museum professionals with an interest in African American history and culture. In recognition of Robert Smith's generosity, the museum's second-floor Explore Your Family History Center and first-floor family pavilion are named in his honor. The gift is the largest single gift the museum has received.

In October 2004, the Smithsonian Board of Regents appointed Oprah Winfrey a founding member of the National Museum of African American History and Culture Council. In the dozen years since, leading up to the museum building's opening on the National Mall on Sept. 24, 2016, she has been a dedicated volunteer and philanthropic leader whose involvement has been critical to this historic project and the realization of this long-awaited dream. With philanthropic contributions from The Oprah Winfrey Charitable Foundation, Oprah Winfrey helped establish the museum's nucleus fund in 2008, made a gift of \$12 million in 2013 and presented an additional gift of \$8 million in 2016. In total, her support to the museum through her foundation is \$21 million, which makes Oprah Winfrey the museum's largest donor. In addition, she has helped build the museum's collection by contributing objects from her personal collection. With her deep commitment, she has played a vital role in bringing the museum's narrative of the African American experience to the nation and the world, so that a more complete American story now may be shared with all.

With a \$1 million gift to the National Museum of African

A gift of \$2 million from Bank of America supported Grand Opening Activities at the Smithsonian's National Museum of African American History and Culture on Sept. 24, 2016. Over 100,000 attendees participated in the dedication ceremony, which featured remarks by President Barack Obama, Rep. John Lewis, former President George W. Bush and the museum's founding director, Lonnie Bunch. The museum chronicles the role African Americans have had in shaping America through 85,000 square feet of exhibition space and thousands of objects. Bank of America has previously made gifts to this museum and 14 other Smithsonian museums, research centers and programs.

BROWN CAPITAL MANAGEMENT



A gift of \$1 million from Brown Capital Management helped the Smithsonian achieve its most recent major milestone, the completion of the National Museum of African American History and Culture on the National Mall. After more than 100 years as a concept, and in the planning and construction phases for more than a decade, the museum's grand opening weekend in September 2016 made national headlines and drew thousands of visitors to participate in its dedication. This is Brown Capital Management's first gift to the Smithsonian.

A \$1 million gift from the Kobe and Vanessa Bryant Family Foundation to the National Museum of African American History and Culture helped fuel the completion of the Smithsonian's 19th museum. 
SUSAN BREAKEFIELD FULTON

work of the Smithsonian Conservation Biology Institute as it advances vital research to understand and sustain threatened species and their habitats worldwide. At facilities in Front Royal, Va., and the National Zoological Park, as well as at research stations and in the field worldwide, institute researchers and scientists apply the study of ecology, genomics, sustainability, behavior and reproduction to help endangered species including the black-footed ferret and scimitar-horned oryx, both of which have been successfully reintroduced to the wild with institute help. This is the largest gift to the Smithsonian to date from the donor, a member since 2002.

The Smithsonian's newest museum, the National Museum of African American

History and Culture, invites visitors to examine their own cultural and historical influences by enabling conversations on diversity. A \$1 million gift from James T. and Juliette J. George advances the museum's mission of broadening perspectives by telling stories of strength, sacrifice and aspiration from a perspective that is uniquely African American, yet informs the experiences of every American. The couple have been donors to the museum's capital campaign since 2014.

JOSEPH L. AND EMILY K. GIDWITZ MEMORIAL FOUNDATION

A \$1 million gift by the Joseph L. and Emily K. Gidwitz Memorial Foundation establishes an endowment for the acquisition of portrait photography at the National Portrait Gallery. Photography comprises more than half the exhibitions on public view and a majority of the portraits acquired over the last several years. The gift is one of the largest in the museum's history and the first to establish an endowment dedicated to the expansion of its collections. This gift, the donor's first to the Portrait Gallery, ensures the museum can continue to portray the people who shape America's evolving cultural identity in crisp detail.

GLAXOSMITHKLINE



A \$2 million gift by GlaxoSmithKline helped the Smithsonian realize the long-awaited dream of the design,

construction and opening of its newest museum, the National Museum of African American History and Culture. The African American story is one of perseverance, fortitude and immense achievement, celebrated in this new museum through more than 3,000 objects from history, music, sports, art, performing arts and the military on display alongside changing exhibitions and educational programs. Among GlaxoSmithKline's founders were leaders in the abolitionist movement, including William Allen, a passionate campaigner against slavery.

MARY LIVINGSTON GRIGGS AND MARY GRIGGS BURKE FOUNDATION

A \$2 million pledge by the Mary Livingston Griggs and Mary Griggs Burke Foundation establishes an endowment to support the Japanese art program at the Freer | Sackler. The endowment, named in honor of the late Mary Griggs Burke, will enhance the museum's Japanese art exhibitions, research and programming, as well as its Japanese art conservation. With over 11,000 objects spanning more than four millennia, the galleries' Japanese art collection is a central part of a dynamic crossroads of art where East meets West.

WILLIAM H. GROSS



With his gift of \$1 million to the National Postal Museum, William H. Gross continues his deep

commitment to the conservation, preservation and education of the public about the value and beauty of postage stamps. This most recent gift establishes an endowment to support the museum's stamp gallery, which is named in the donor's honor, and which with 200,000 objects on display is the largest gallery in the world dedicated to philately. The museum intends to build on the endowment with additional gifts. William H. Gross has given more than \$10 million to the museum since 2009, including the lead gift that helped make possible the creation of its stamp gallery.

LYDA HILL

A gift by Lyda Hill of \$1.15 million energizes the National Museum of Natural History's transformation of its iconic dinosaur and fossil hall, which reopens in 2019. The funds support fabrication and construction of Deep Time, a 31,000-square-foot exhibition that explores how ancient forces have shaped all life on Earth and promotes understanding of our place in Earth's history. The gift also supports a scientist working in geologic research and Outbreak, an upcoming exhibition about the interconnectedness of human, animal and environmental health. This is Lyda Hill's largest gift to the natural history museum.

THE ROBERT H.N. HO FAMILY FOUNDATION

A gift by The Robert H.N. Ho Family Foundation enables the Freer | Sackler to open Encountering the Buddha: Art and Practice Across Asia in October 2017. The exhibition offers "encounters" through art; immersive spaces, including a recreation of a Tibetan Buddhist shrine with over 200 sculptures, thangkas and ritual objects; and a film of present-day worshippers at a sacred site in Sri Lanka. The centrality of pilgrimage within Buddhist tradition is conveyed by a digital interactive on Hyecho, the Korean monk who traveled across the Buddhist world in the 8th century. The foundation has supported the Freer | Sackler since 2010.

CATHY HUGHES AND ALFRED C. LIGGINS III



By making their \$1 million gift to the design and construction of the National Museum of African American

History and Culture, Cathy Hughes and her son, Alfred C. Liggins III, helped the Smithsonian realize a dream more than a century in the making. Now in its newly opened building, the museum continues to show the nation and the world how central African American innovation is to the American dream of economic opportunity. Cathy Hughes has been a Charter Member of the museum since 2012.

JOHNSON & JOHNSON

Johnson-Johnson

With its gift of \$2 million to the National Museum of African American History and Culture, Johnson & Johnson assisted with the final phases of the design and construction of the Smithsonian's newest museum on the National Mall. Her first gift came by way of the Reginald F. Lewis Foundation, founded by her late husband in 1987, of which she is now chair. Mr. Lewis is represented in the museum with a copy of his biography, "Why should white guys have all the fun?", his briefcase and his nameplate.

THE JOHN D. AND CATHERINE T. MACARTHUR FOUNDATION

MacArthur Foundation

A \$2 million gift by The John D. and Catherine T. MacArthur Foundation assisted with the final push to complete the design and construction of the Smithsonian's newest museum, the National Museum of African American History and Culture. It opened in September 2016, more than a dozen years after its authorization by Congress in 2003 and more than 100 years after the idea for the museum was first conceived. The museum's artifacts, stories and educational programming share how American values such as resiliency, optimism and spirituality are deeply embedded in African American history and culture. After a century as a deferred dream and more than a decade in planning and construction, the museum now has come to life, evidence that freedom did ring, is ringing and continues to ring for equality and human rights. Rose A. McElrath-Slade has supported the museum since 2013.

MEDTRONIC FOUNDATION

A \$2 million gift from the Medtronic Foundation provided momentum into the final phase of design and construction of the National Museum of African American History and Culture, which opened with more than 100,000 people in attendance. Its collections encompass more than 36,000 artifacts, and the museum holds regular film screenings, book readings and discussions to help all Americans learn how their personal histories and stories continue to be shaped by the African American experience.





The Tennenbaum Marine Observatories Network's program in environmental and biodiversity research launched new observatory sites with partners in British Columbia, Washington state, Hawaii and Tasmania to complement long-term Smithsonian research along the east coast of North and Central America. Scientists at the sites measure biodiversity and ocean temperature, acidity, and water quality, and conduct experiments and modeling to understand how coastal ecosystems respond to change.


